**1. Services.** Service Provider retained by the Client for Bee Relocation Service. Provider and Client agree to all terms set forth: Service Provider agrees to use professional principles and practices in accordance with industry standards when rendering Services. Provider agrees that performance shall reflect the best professional knowledge, skill and judgment for Services. Services include removal of bees inside a structure, removal of remaining hive(s) and repair of the area with original material, wood, trimming, shingles, etc. Unsatisfactory work or bees present after 72 hours should be reported for resolution. (469) 825-5218. Mon - Fri 8 a - 7p.

**2. Service Requirements:** The Services delivered conform to (i) Services and the specifications set in (ii) Service Requirements. The Client agrees to (i) Services, (ii) Service Requirements and (iii) Terms. Service Requirements include: humane removal of bees from structure, removal of hive and repair of area with original material removed. (wood, trimming, shingles, etc.) Relocation of Bees to local Apiary/Owned Apiary. Repair work performed by Provider is subject to a 1 year warranty from the date of Service. Wasp Services are for extermination and are limited to a 20 day warranty. Clients are able to retain bees from removal if a bee box "hive" is available for transition, otherwise bees are collected by Provider. Warranty specified in notes.

**3. Terms:** Due to the nature of service: Client is aware that services performed are dangerous and we advise against spectating. Honey bees are known to be defensive insects that will sting nearby Humans, Pets or Objects. Services are Work for Hire. Services produced belong exclusively to the client once completed. Modifications to work produced can only be made by the Provider. Altered work product voids warranty. No Finish Work: Paint, Stucco & Brick. Damage to structure/property is subject to repair or replacement as agreed by both parties. Provider agrees to conduct safe practices during the removal procedure and only provides edible honey back to the client when honey from the beehive is available. Clients are aware stinging can occur during inspections/services. Provider, contractors and representatives are not responsible for injuries to clients from bees. Client is not responsible for injuries to the Provider. Provider reserves the right to decline service before beginning work. Client reserves the right to cancel services before work has begun. Once services begin Provider must complete work per danger of bees. Failure to comply with the terms imposed by Provider voids this agreement and excludes Provider from liability and legal remedies.

**4. Payment:** The Client agrees to pay the Provider fee for services completed after services are performed. The provider shall incur no fee from any services performed for Client. Payment arrangements are specified in agreement.

**5. Media:** Before, during and after images/videos of bee removal process are shared with Client when files are ready. Media files are kept by the Provider for marketing use. Clients Information is never sold or shared.
